WEST HARBOR MARINA, LLC (WHM) **INSIDE HEATED STORAGE POLICY**

- All haul-out arrangements must be made prior to October 15th.
- Contact the office 419-734-2226 for access to your boat.
- WHM reserves the right to keep boats inside of the building until approximately April 1st or later if weather conditions do not permit for reasonable removal.
- WHM reserves the right to move the boats outside after April 1st or sooner if weather permits without notice.
- If Customer is not present at the time of the boat launch into the water, Customer will be responsible for any additional labor and material charges incurred by WHM for getting boat started, moved to the dock, etc.
- All boats and any other stored watercraft, vehicles, or other items still on WHM property by June 1st shall have a \$10.00 per day storage fee, plus a cost for a relocation fee if necessary. After June 1st, said items may be relocated to another outside storage area by WHM.
- WHM shall provide all service on boats stored within the heated storage unless WHM determines at its discretion that it cannot provide the requested service. Outside contractors must be approved in order to work on WHM property and must have proper insurance and licensing. All Subs need prior approval and pre-arranged schedule times. Customer is responsible for any damage caused by an outside contractor hired by Customer.
- Owners, his/her agents, guests shall comply with all rules & regulations established by WHM and shall not engage in illegal or immoral activities while on WHM property that would be in violation of city, state or federal guidelines.
- Please be courteous of all neighboring boats and the facility! Clean up after yourself and after any work performed on your boat. Customer shall be responsible for returning any neighboring boat(s) and the facility to the same condition as it was prior to any work being performed by Customer or Customer's subcontractors that may cause dust, damage, etc. Do not leave any trash in the building – take any trash with you. Do not leave any loose items on the ground around your boat. **NO PAINTING, FIBERGLASS OR GEL COAT WORK IS PERMITTED INSIDE THE BUILDING(S)!**
- Do not leave anything plugged in when you are not present.
- WHM shall not be held responsible or have any liability for any loss or damage to Customer's boat (including tools, accessories, or safety equipment), or any personal belongings of Customer occasioned by theft, fire, flood, windstorm, or other cause beyond the reasonable control of WHM and Customer shall cover said risks by insurance without subrogation against WHM. Note that proof of insurance with at least \$500,000 in coverage is required for all boats stored with WHM. Please provide proof of insurance with "West Harbor Marina LLC" named as an additional insured before storing your boat. No boat is permitted inside a building or on WHM property without proof of insurance on file with WHM. Thank you!
