NO BOAT WILL BE LAUNCHED THAT IS NOT PAID IN FULL UNLESS YOU HAVE COMPLETED THE PAYMENT PLAN BELOW. NO BOAT IS PERMITTED AT A BOAT SLIP IF ANY PAYMENTS ARE OUTSTANDING. WEST HARBOR MARINA RESERVES THE RIGHT TO PULL ANY BOATS THAT ARE AT A DOCK WITHOUT BEING PAID IN FULL OR OTHERWISE AGREED AND THE CUSTOMER SHALL BE RESPONSIBLE FOR ANY CHARGES ASSOCIATED THEREWITH. ANY AND ALL PAYMENTS MADE TOWARD DOCKAGE ARE NONREFUNDABLE.

THERE WILL BE A \$30.00 FEE FOR ANY RETURNED CHECK.

TERMS AND CONDITIONS OF CONTRACT

SUMMER DOCKAGE SEASON: April 15th through October 15th

NO REFUELING of boats from portable containers. Dockage cancelled for violators.

DOCK BOXES must be standard white factory-made unless otherwise approved by management. WHM reserves the right to remove and dispose of any homemade storage bins or other junk items left around the dock areas.

TWO (2) VEHICLE LIMIT per dock. No parking of motor homes. Overnight staying is permitted ONLY on vessels which are in the water.

DOCK POLE RESTRICTIONS: No carpeting allowed on dock poles or dock walk areas. Absolutely no duct tape on docks. Anything attached to docks or uprights must be removed at season's end. Steps may not be fastened to the docks and the size cannot obstruct your dock partner's passage and use of said dock.

SUBLEASING PROHIBITED: This agreement is NOT transferable without consent of management.

OUTSIDE CONTRACTORS: If you hire an outside contractor, they must notify management each time they are doing work on your boat and have a certificate of insurance on file with WHM. No major repairs will be done at WHM unless authorized by management.

TERMINATION: Upon breach of contract, WHM may cancel or terminate your contract immediately without any refund.

TRAILERS: No trailers will be stored on premises of WHM except those for which a summer or temporary storage agreement has been entered into with management. All trailers will be hauled away at owner's expense.

ELECTRIC: No refrigerators, heaters, air conditioners, fans, or other electric appliances are to be run needlessly. Disconnect when you leave. There may be additional charges for boat air conditioners left running when you are not at your boat. WHM reserves the right to turn off electric to any boat. No GFI's provided at docks, boat owners must provide their own GFI.

COMMERCIAL ACTIVITY: No solicitations or commercial enterprise permitted in marina unless authorized by management. Any signage and commercial equipment including fish racks must also be approved by management.

GRILLS: Absolutely no grills allowed on boats or docks. No ground fires or fire pits permitted anywhere.

DOCK LOCATION: WHM reserves the right to move any vessel for reasons deemed necessary.

SWIMMING: No swimming permitted in the harbor of WHM

CHILDREN: Children, including teenagers, must be accompanied by an adult. Children under 8 years of age must wear a life jacket. Warn children not to throw stones into the harbor. No running or playing on or around docks. Docks may be slippery when wet. Please use caution.

SMALL WATERCRAFT: No jet skis, rafts, dinghies, or other small watercraft are to be tied off boats or boat slips for long-term storage without authorization of management.

FISH CLEANING is strictly prohibited. Absolutely no fish or entrails to be deposited in the dumpster or in the water.

COMMON SENSE: No tenant, guests, radios, or TV's will be permitted to annoy others. Loud or boisterous conduct or profanity will not be tolerated. Everyone must conduct themselves in a peaceful and orderly manner so as not to disturb other customers or the general operations. Criminal activity and/or inappropriate behavior will be cause for immediate removal of the person and/or watercraft from WHM property at the discretion of WHM.

PETS must be kept on leashes at all times and must not be left unattended. Owners must clean up immediately after their pet and wrap and seal all pet waste before disposal into the dumpster.

OCCUPANCY: No person shall reside on their boat. Any person staying on their boat more than the standard summer usage may be charged additional usage charges for electric, water, etc.

EMERGENCY: Call 911 for emergencies.

INSURANCE: WHM shall not be held responsible or have any liability for any loss or damage to Customer's boat (including tools, accessories, or safety equipment), or any personal belongings of Customer occasioned by theft, fire, flood, windstorm, or other cause beyond the reasonable control of WHM and Customer shall cover said risks by insurance without subrogation against WHM. Note that proof of insurance with at least \$500,000 in coverage is required for all boats docked stored with WHM. Please provide proof of insurance with "West Harbor Marina LLC" named as an additional insured before docking your boat. No boat is permitted at a dock or on WHM property without proof of insurance on file with WHM.
