## TERMS AND CONDITIONS OF CONTRACT

By obtaining a West Harbor Marina (WHM) pool membership, all pool members and their guests hereby acknowledge and agree to the rules below and as posted in and about the WHM swimming pool and bathhouse areas. The undersigned further acknowledge that they will be provided with (1) key card. Replacement key cards will be available for \$10 each. We ask that you do NOT provide access to the facilities to anyone that does not present a key card and, in turn, we ask that you do NOT attempt to gain access to any of the facilities without a key card. (This will prevent unauthorized persons from unauthorized use of the pool area.)

1. SUMMER POOL SEASON: Memorial Day through Labor Day. Pool members may have to pay for pool access during any special event(s) outside of the pool season such as Harbor Bash.
2. POOL HOURS: 8:00am-10:00pm unless otherwise posted.
3. NO LIFEGUARD ON DUTY. No one under age 12 permitted in pool area without a responsible adult present.
4. Please accompany small children to the restroom and also ask them periodically if they need to use the restroom to help avoid any accidents in the pool.
5. WHM pool memberships are limited to a family with no more than two (2) adult and two (2) minor family members unless otherwise approved by WHM. Guests must be registered for an additional charge of \$5 per person if more than four (4) people are using the same membership per day. Any guests must be accompanied at all times by a WHM pool member at least 12 years old when using the pool area.
6. WHM pool facility is used at your own risk. WHM is not responsible for lost, damaged or theft of personal property.
7. NO SMOKING in the pool area or in the bathhouse.
8. NO dogs in the pool area.
9. NO seat reservations. If you are not using a lounge chair, table or seat, your belongings may be moved.
10. NO OUTSIDE COOLERS, FOOD, OR DRINK UNLESS PURCHASED FROM BOONDOCKS BAR. NO GLASS IN THE POOL AREA. NO INSULATED CUPS.
11. Any damage to the pool area by members or their guests will be charged to the member.
12. This agreement is NOT transferable without consent of WHM.
13. Upon breach of contract, WHM may cancel or terminate your contract immediately without any refund.
14. Anyone over age 4 must wear appropriate swimming attire that provides adequate coverage. Children that are not toilet-trained must wear a swim diaper.
15. No solicitations or commercial enterprise permitted in pool area unless authorized by management.
16. No swimming permitted in the harbor of WEST HARBOR MARINA.
17. NO running on the decks around the pool area. NO playing on or around docks. Decks and docks may be slippery when wet. Please use caution. Warn children not to throw rocks or stones into the harbor.
18. NO flipping or diving into the pool.
19. NO horseplay in or around the pool area that may result in injury or disturb others. No member, tenant, guests, or electronic devices will be permitted to annoy others. Loud or boisterous conduct or profanity will not be tolerated.
20. The pool may be closed for maintenance at the discretion of WHM.
21. All trash shall be disposed of in the property trash receptacles.
22. Anyone with a communicable medical condition is prohibited from using the pool area.
23. Call 911 for emergencies.
